GENERAL SERVICE WASTEWATER RATE SCHEDULE GI**

AVAILABILITY

This rate schedule shall apply to wastewater service to commercial, industrial, governmental and other customers, not classified as residential, located within the corporate limits of the City of Jackson. The rate is based upon the amount of water measured by JEA's metering facilities at each point of delivery.

RATE

Customer Charge: \$16.95 per month

Wastewater Charge:

First 500,000 gallons per month at \$0.5097 per 100 gallons

Next..... 500,000 gallons per month at \$0.4617 per 100 gallons

Excess over 1,000,000 gallons per month at \$0.3178 per 100 gallons

Surcharge:

Carbonaceous Biochemical Oxygen Demand (CBOD) over 450 mg/l..... \$0.1649 per pound

Suspended Solids (SS) over 500 mg/l \$0.1305 per pound

Fats, Oil and Grease over 100 mg/l \$0.1305 per pound

MINIMUM MONTHLY BILL

The customer charge of \$16.95 constitutes the minimum monthly bill.

SPECIAL MONTHLY BILL

Any customer discharging wastewater, other than normal strength waste and flow, into JEA's wastewater system is subject to the requirements of JEA's WASTEWATER SYSTEM USE REGULATIONS and will pay (in addition to the wastewater charges) the appropriate surcharges based on the characteristics and strength of the wastewater.

PAYMENT

Bills under this rate schedule will be rendered monthly. Any amount of bill unpaid after due date specified on bill may be subject to additional charges under Jackson Energy Authority's standard policy.

SINGLE-POINT DELIVERY

The above rates are based upon the supply of service through a single delivery and metering point. Separate supply for the same customer at other points of consumption shall be separately metered and billed.

Service under this classification is subject to Rules and Regulations of JEA.

AVAILABILITY

This rate schedule shall apply to wastewater service to commercial, industrial, governmental and other customers, not classified as residential, when available from JEA's distribution system outside the corporate limits of the City of Jackson. The rate is based upon the amount of water measured by JEA's metering facilities at each point of delivery.

RATE

Customer Charge: \$21.20 per month

Wastewater Charge:

First 500,000 gallons per month at \$0.6358 per 100 gallons

Next..... 500,000 gallons per month at \$0.5757 per 100 gallons

Excess over 1,000,000 gallons per month at \$0.4018 per 100 gallons

Surcharge:

Carbonaceous Biochemical Oxygen Demand (CBOD) over 450 mg/l..... \$0.2053 per pound

Suspended Solids (SS) over 500 mg/l \$0.1649 per pound

Fats, Oils and Grease over 100 mg/l..... \$0.1649 per pound

MINIMUM MONTHLY BILL

The customer charge of \$21.20 constitutes the minimum monthly bill.

SPECIAL MONTHLY BILL

Any customer discharging wastewater, other than normal strength waste and flow, into JEA's wastewater system is subject to the requirements of JEA's WASTEWATER SYSTEM USE REGULATIONS and will pay (in addition to the wastewater charges) the appropriate surcharges based on the characteristics and strength of the wastewater.

PAYMENT
