### **JACKSON ENERGY AUTHORITY RESIDENTIAL WASTEWATER RATE SCHEDULE RI**

#### **AVAILABILITY**

This rate shall apply to wastewater service for domestic uses in a single private dwelling, including an individual family apartment or mobile home located within the corporate limits of the City of Jackson. The Residential Rate shall not apply to service to institutions such as clubs, fraternities, orphanages or homes; recognized rooming or boarding houses; or to other areas primarily used for professional or other gainful purposes. The rate is based upon the amount of water measured by JEA's metering facilities at each point of delivery.

#### **RATE**

Customer Charge: \$3.77 per month

Wastewater Charge:

First .....	500,000 gallons per month at \$0.4708 per 100 gallons
Next .....	500,000 gallons per month at \$0.4241 per 100 gallons
Excess over .....	1,000,000 gallons per month at \$0.2819 per 100 gallons

#### **MINIMUM MONTHLY BILL**

The customer charge constitutes the minimum monthly bill per family or family unit. When more than one house, building or structure used for living, eating or sleeping quarters uses water through a common meter; or in houses occupied by more than one family and in apartment houses where water is measured by a common meter, the minimum monthly bill shall be the customer charge times the number of family units served through each common meter.

#### **MAXIMUM MONTHLY BILL**

The maximum monthly bill per family or per family unit shall be based upon a maximum usage of 10,000 gallons per month, except for those customers whose normal average use of water exceeds 10,000 gallons per month during the months of November through March, in which case the customer's maximum monthly bill will be based upon the average use during November to March.

#### **FLAT MONTHLY BILL**

Any customer who has water supplied from a well or other non-JEA source, and who requests and receives wastewater service, will be billed for wastewater on a monthly rate based on 10,000 gallons of water use. Customers not connected to JEA water or wastewater system will be billed for wastewater on a monthly rate based on 5,000 gallons use. JEA will supply a water meter, meter connectors, and meter box without additional charge to any customer who feels his/her water consumption should be less than the amount billed; and the customer will make the meter installation (at the customer's expense) on his/her water service line at a location and standard approved by JEA. The customer then would be billed upon the amount of water measured by JEA's metering facilities and at the standard rate. The quality of water from the customer's source shall be free of any contaminants that might be harmful to the meter.

#### **PAYMENT**

Bills under this rate schedule will be rendered monthly. Any amount of bill unpaid after due date specified on bill may be subject to additional charges under Jackson Energy Authority's standard policy.

Effective October 1, 2011

### **SINGLE-POINT DELIVERY**

The above rates are based upon the supply of service through a single delivery and metering point. Separate supply for the same customer at other points of consumption shall be separately metered and billed.

Service under this classification is subject to Rules and Regulations of JEA.

RESIDENTIAL WASTEWATER RATE SCHEDULE RO**

**AVAILABILITY**

This rate shall apply to wastewater service for domestic uses in a single private dwelling, including an individual family apartment or mobile home, when available from JEA's distribution system outside the corporate limits of the City of Jackson. The Residential Rate shall not apply to service to institutions such as clubs, fraternities, orphanages or homes; recognized rooming or boarding houses; or to other areas primarily used for professional or other gainful purposes. The rate is based upon the amount of water measured by JEA's metering facilities at each point of delivery.

**RATE**

Customer Charge: \$4.71 per month

Wastewater Charge:

First ..... 500,000 gallons per month at \$0.5892 per 100 gallons

Next ..... 500,000 gallons per month at \$0.5292 per 100 gallons

Excess over ..... 1,000,000 gallons per month at \$0.3524 per 100 gallons

**MINIMUM MONTHLY BILL**

The customer charge constitutes the minimum monthly bill per family or family unit. When more than one house, building or structure used for living, eating or sleeping quarters uses water through a common meter; or in houses occupied by more than one family and in apartment houses where water is measured by a common meter, the minimum monthly bill shall be the customer charge times the number of family units served through each common meter.

**MAXIMUM MONTHLY BILL**

The maximum monthly bill per family or per family unit shall be based upon a maximum usage of 10,000 gallons per month, except for those customers whose normal average use of water exceeds 10,000 gallons per month during the months of November through March, in which case the customer's maximum monthly bill will be based upon the average use during November to March.

**SPECIAL MONTHLY BILL**

Any customer who has water supplied from a well or other non-JEA source, and who requests and receives wastewater service, will be billed for wastewater at the standard rate for the amount of water measured by JEA's metering facility installed on the customer's water service line. JEA will supply a water meter, meter connectors, and meter box without additional charge; and the customer will make the meter installation (at the customer's expense) on his/her water service line at a location and standard approved by JEA.

**PAYMENT**

Bills under this rate schedule will be rendered monthly. Any amount of bill unpaid after due date specified on bill may be subject to additional charges under Jackson Energy Authority's standard policy.

The above rates are based upon the supply of service through a single delivery and metering point. Separate supply for the same customer at other points of consumption shall be separately metered and billed.

Service under this classification is subject to Rules and Regulations of JEA.

Effective October 1, 2011
