### JACKSON ENERGY AUTHORITY

#### RESIDENTIAL WATER RATE SCHEDULE RI

##### AVAILABILITY

This rate shall apply to water service for domestic uses in a single private dwelling, including an individual family apartment or mobile home located within the corporate limits of the City of Jackson. The Residential Rate shall not apply to service to institutions such as clubs, fraternities, orphanages or homes; recognized rooming or boarding houses; or to other areas primarily used for professional or other gainful purposes.

##### RATE

First .....	2,000	gallons per month at \$0.5240 per 100 gallons
Next.....	5,000	gallons per month at \$0.3787 per 100 gallons
Next.....	43,000	gallons per month at \$0.3155 per 100 gallons
Excess over .....	50,000	gallons per month at \$0.2048 per 100 gallons

##### MINIMUM MONTHLY BILL

5/8" Meter -	\$ 10.48 per month	1 1/2" Meter -	\$32.61 per month
1" Meter -	\$20.13 month	2" Meter -	\$63.78 per month

Where more than one house, building or structure used for living, eating or sleeping quarters uses water through a common meter; or in houses occupied by more than one family and in apartment houses where water is measured by a common meter, the minimum monthly bill shall be \$10.48 times the number of families served through each common meter. Separate houses, multi-family residences and apartment houses with less than 40 family units served through a common meter shall be billed under the above rate schedule as if each family unit were separately metered. In apartments or other residential projects with 40 or more family units served by one meter, the customer will be billed for the total amount of water used under the above rate schedule when the net bill exceeds the minimum charge as provided herein.

##### PAYMENT

Bills under this rate schedule will be rendered monthly. Any amount of bill unpaid after due date specified on bill may be subject to additional charges under Jackson Energy Authority's standard policy.

##### SINGLE-POINT DELIVERY

The above rates are based upon the supply of service through a single delivery and metering point. Separate supply for the same customer at other points of consumption shall be separately metered and billed. Service under this classification is subject to Rules and Regulations of the Authority.

Next.....	5,000	gallons per month at \$0.5321 per 100 gallons
Next.....	43,000	gallons per month at \$0.3891 per 100 gallons
Excess over .....	50,000	gallons per month at \$0.2165 per 100 gallons

**MINIMUM MONTHLY BILL**

5/8" Meter -	\$15.61 per month	1 1/2" Meter -	\$48.17 per month
1" Meter -	\$29.51 per month	2" Meter -	\$94.99 per month

Where more than one house, building or structure used for living, eating or sleeping quarters uses water through a common meter; or in houses occupied by more than one family and in apartment houses where water is measured by a common meter, the minimum monthly bill shall be \$15.61 times the number of families served through each common meter, and the total charge for such service shall be billed under the above rate schedule as if each family unit were separately metered.

**PAYMENT**

Bills under this rate schedule will be rendered monthly. Any amount of bill unpaid after due date specified on bill may be subject to additional charges under Jackson Energy Authority's standard policy.

**SINGLE-POINT DELIVERY**

The above rates are based upon the supply of service through a single delivery and metering point. Separate supply for the same customer at other points of consumption shall be separately metered and billed.

Next.....	185,000 gallons per month at \$0.3155 per 100 gallons
Next.....	300,000 gallons per month at \$0.2018 per 100 gallons
Next.....	500,000 gallons per month at \$0.1754 per 100 gallons
Excess over .....	1,000,000 gallons per month at \$0.1267 per 100 gallons
