

**JACKSON ENERGY AUTHORITY**  
**RESIDENTIAL GAS RATE SCHEDULES**

**AVAILABILITY - GENERAL**

These schedules are available to residential customers for domestic use in individual dwelling units. Private dwellings in which space is occasionally used for the conduct of business by a person residing therein will be served under this rate schedule. Where a portion of the dwelling is used regularly for the conduct of business, the gas consumed in that portion so used will be separately metered and billed under another appropriate gas rate. If separate piping, which permits separate metering is not provided by the customer, the entire premises shall be classified as non-residential and billed accordingly. The Residential Schedule shall not apply to service to multiple dwelling units or to institutions such as clubs, fraternities, orphanages, or homes; recognized rooming or boarding houses; the space in an apartment or other residential building primarily devoted to use as an office or studio for professional or other gainful purposes.

Gas supplied under this schedule is for the exclusive use of the customer and shall not be resold or shared with others.

**BILLING UNITS**

Gas supplied under these schedules will be measured in units of one hundred cubic feet (CCF) corrected to a pressure base of 14.65 psig, then converted to therms based on the heat content of one CCF. Billing units will be therms.

**RATE SCHEDULE R-1**

Rate Schedule R-1 is available to residential customers located within the corporate limits of the City of Jackson, Tennessee.

**PURCHASED GAS ADJUSTMENT**

The monthly rates are subject to provisions of the Purchased Gas Adjustment Rider to Natural Gas Rate Schedules effective December 1, 1989.

**MINIMUM MONTHLY BILL**

During the summer season, May to September inclusive, there will be no customer charge, and no bill rendered until the charge for gas consumed since the last bill shall equal or exceed the above stated customer charge.

**PAYMENT**

Bills under this rate schedule will be rendered monthly. Any amount of bill unpaid after due date specified on bill may be subject to additional charges under Jackson Energy Authority's standard policy.

**SINGLE-POINT DELIVERY**

The above monthly rates are based upon the supply of service to the customer's premises through a single delivery and metering point and at a single pressure. Separate supply for the same customer at other points of consumption, or at different pressures, shall be separately metered and billed.
